start the school year off with new clothes, shoes, and school supplies with it's Child Spree Program.
This support is critical to families whose children would otherwise be unprepared for the new school
year. For several years The Salvation Army has worked with school district liaisons to identify needy families, and
worked with Walmart in Lake Elsinore to provide breakfast and a time for children to pick out \$125 worth of
new school clothes and supplies. Children also can choose three new books thanks to the Ella Fitzgerald Foundation.
Volunteers from the City of Lake Elsinore are also utilized to make Child Spree a fun day for both the children
and their parents.

If awarded, The Salvation Army would purchase 40 \$125 gift cards to be used the day of the event.
Volunteers and Staff hand the gift cards to the cashiers and they carefully monitor that the items being purchased
are only school clothes and chose for the specific child. This ensures the integrity and accountability of the program
Children will choose a backpack and school supplies but funding for those items are from internal funding.

The Salvation Army works with the Lake Elisnore School District to identify children who would
benefit from the child spree program. They understand the boundries of funding and only refer children who
live in the city limits. This grant funding will allow us to assist 40 children, however we hope to serve at
least 80 children. 12-18 volutneers are utilized for the event.
