The City of Lake Elsinore appreciates your attendance. Public participation provides the Public Safety Advisory Commission with valuable information regarding issues of the community.

Regular meetings are held on the 3rd Wednesday of every month.

To protect our constituents, City officials and City staff, members of the public are requested to follow the California Department of Health Services' guidance and the County of Riverside Public Health Officer Order for the Control of COVID-19.

Guidance issued by the California Department of Health Services on June 18, 2020 requires that members of the public wear face coverings in high -risk situations, which includes when inside of, or in line to enter, any indoor public space. Social distancing is also required in addition to wearing face coverings.

In order to comply with these guidelines, persons entering the Cultural Center must wear face coverings and observe social distancing.

In addition, only a limited number of people will be permitted in the Cultural Center at the same time in order to maintain social distancing. Those wishing to speak will be provided a speaker 's form to fill out, which forms will also be made available directly outside of the Cultural Center. Members of the public wishing to address the Commission may have to wait outside of the Cultural Center until their name is called.
