Pooled Money Investment Account Monthly Portfolio Composition ⁽¹⁾ 04/30/22 \$225.5 billion

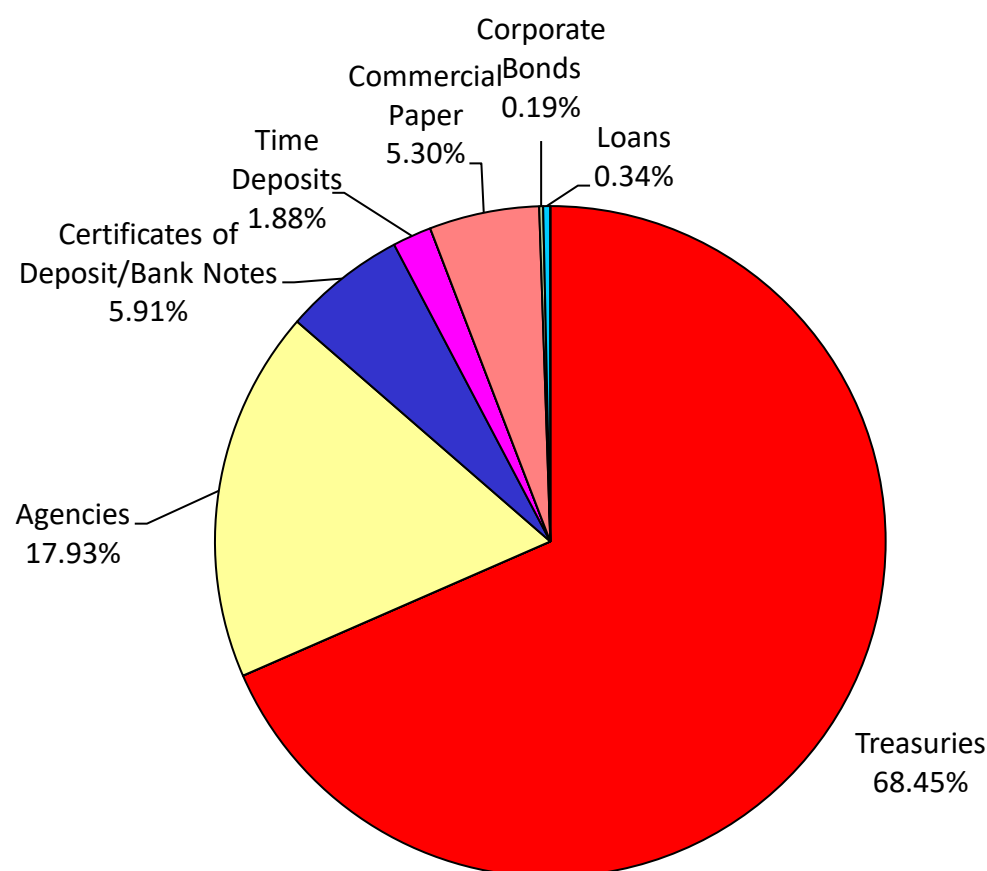

Investment Portfolio



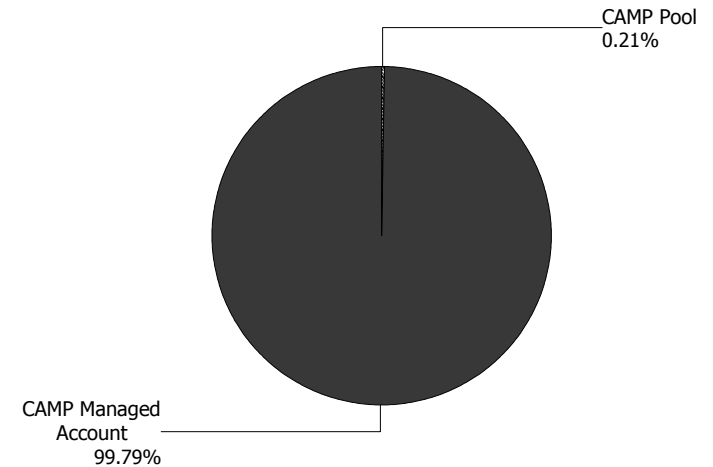

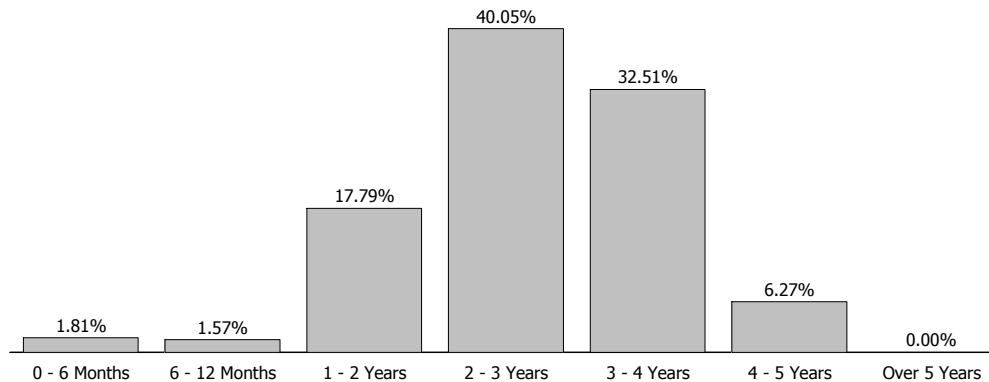

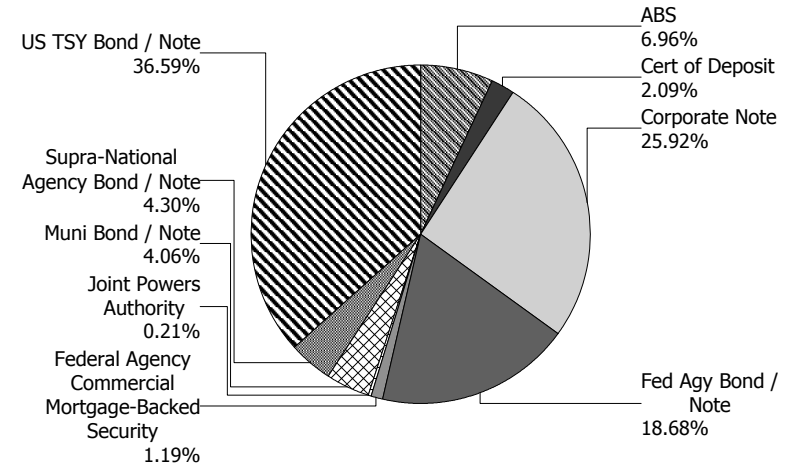

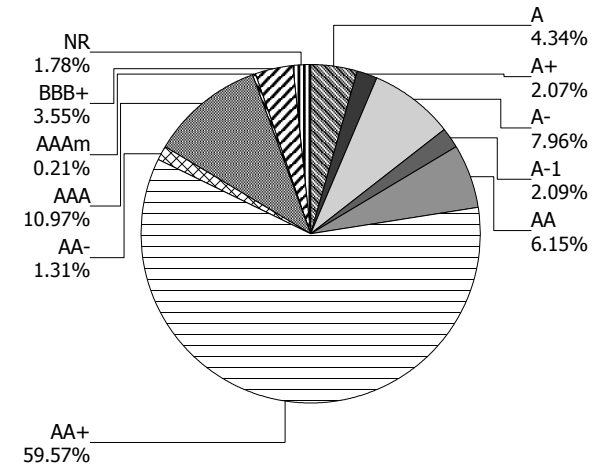
