- Production of (1) NEW 30-minute film featuring the Dream Extreme Fishing Derby. This film will air on FOX Sports West (HD) at least four (4) times each during the term of agreement. Angler Chronicles airs on Sundays at 8:30 AM and Tuesdays at 2:00 PM.
- Angler Chronicles will also air the episode already produced for the Lake Elsinore Fishing Derby. This is a total of two (2) films with at least six (6) airings during the term of agreement.
- One (1) 30-second Television commercial promoting the City of Lake Elsinore, to be aired weekly on Angler Chronicles TV (Fox Sports West & Fox Prime Ticket).
