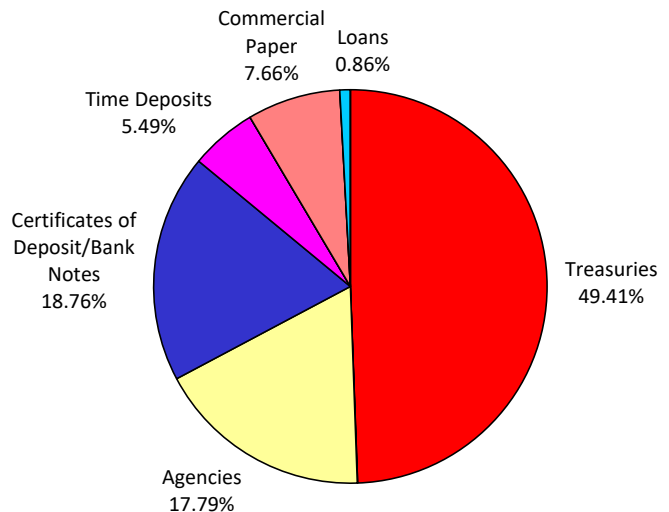

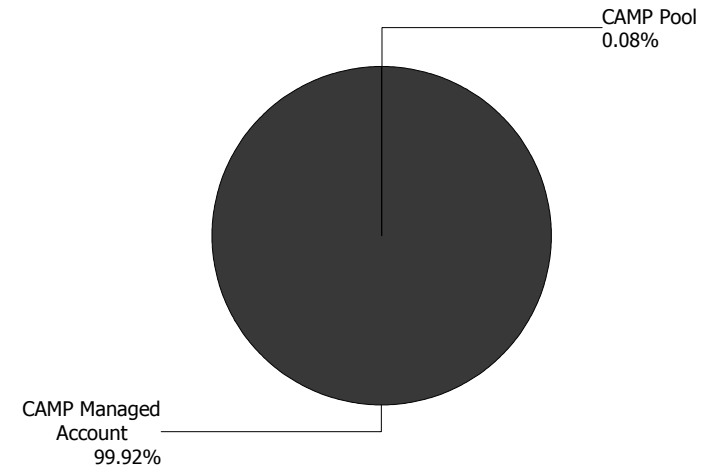

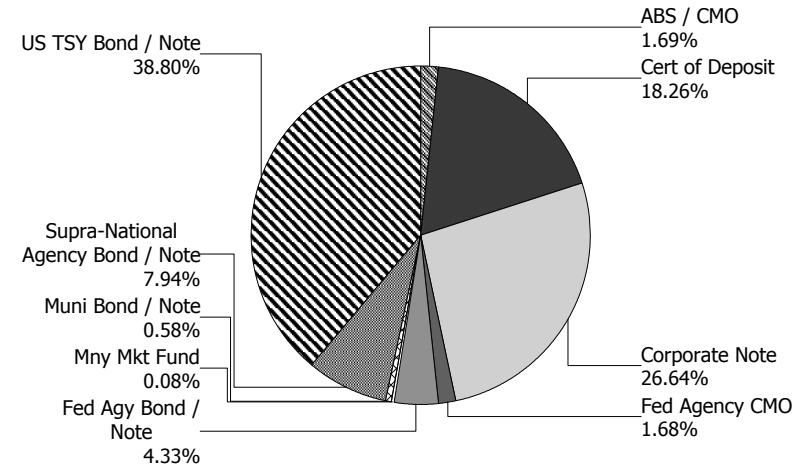

Sector Allocation



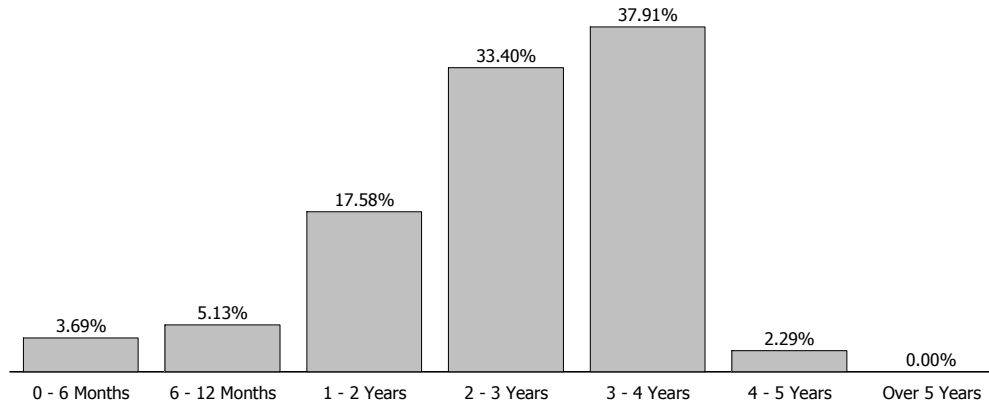

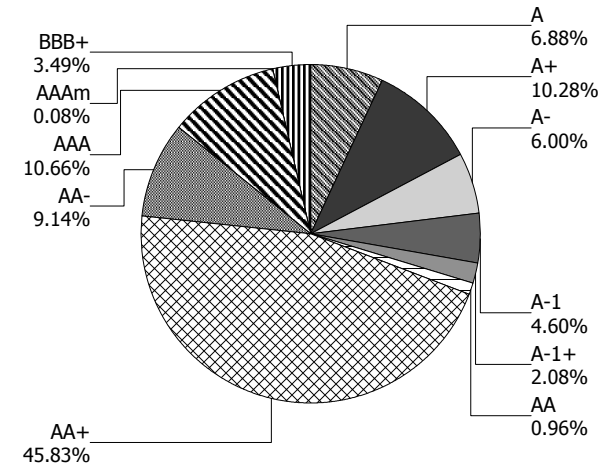
