

# City of Lake Elsinore Planning Commission Meeting Minutes Tuesday, August 15, 2017

## **CALL TO ORDER**

A Regular meeting of the Planning Commission of the City of Lake Elsinore was held in the Cultural Center, 185 North Main Street, on the above date. The meeting was called to order at 6:01 p.m. by Chairman Gray.

It was moved by Chairman Gray, seconded by Commissioner Carroll, and unanimously carried, noting the absence of Commissioner Armit, to approve meeting minutes.

The Public Hearing was opened at 6:03 p.m. There were no conflict of Interest disclosures. Administrative Clerk Wells affirmed receipt of Proof of Publication and noted that correspondence had been received.
