To honorable Mayor Magee and the Lake Elsinore City council,

On 10/24/2017, you will be presented with a recommendation to approve the Cottages affordable housing project by Civic Partners. I implore you to please take a moment and consider our objections and points outlined below. We understand that the city is mandated to supply a percentage of affordable units. We respectfully ask the city council to consider a compromise and either scale down this project to a more manageable size within the developers budget or divide it and placing the units in various sites throughout the city.

I have outlined additional concerns below and pray that the city council puts aside any unfounded opinions against the petitioners and seriously takes into consideration our concerns before approving the development. I think there is room for compromise that will satisfy the city's commitment to provide affordable housing and also satisfy the concerned residents below.

- 1. High concentration of affordable housing units surrounding the lake. This is creating an "Inner City" feel. I took the liberty of plotting the city's 5 existing low income apartments listed on your website and in addition, the planned Cottages and Mission Trails units. I think you can clearly see that within the Lake Elsinore city limits, these affordable housing units are concentrated around the lake, creating an "inner city". We strongly believe that these units need to be distributed evenly throughout the city boundaries, so as to not create areas of concentrated lower incomes.
- 2. Surrounding home values dropping because of the proximity of these units. Many believe that home values drop once work force housing is constructed. There is no way to be certain because I have found articles both in favor and against this theory. The homeowners of the Summerly Development were not made aware of these proposed complexes (Cottages and Mission Trail Apartments) prior to purchase. Had it been disclosed at the time of purchase, we feel many would not have purchased homes here. It was just brought to my attention today that the city has had pre designated areas for affordable housing, as far back as 2002? If this is true, then we ask the city to release any other known potential sites that are designated for low income/ affordable housing so future home buyers can make informed decisions prior to purchase.

3. Civic Partners has limited experience in work force housing projects


http://www.civicpartners.com/project.htm. As Mayor Magee pointed out at the 8/8/2017 city council meeting, in order for these projects to be successful, they must be well managed and maintained. I appreciated the fact that C&C developers were vested and committed to their Mission Trails Apartments project and vowed to never sell their project and remain involved at all times http://www.c-cdev.com/. This project will need accountability to ensure they are being good neighbors. I was only able to locate two affordable housing developments by Civic Partners, Renaissance Terrace in Long Beach built in 1987 and City Terrace in Long Beach built in 1988. Both had mixed reviews on Google and Yelp the highest rating was a 3 star.

- 4. Scale and funding of this project, the developer is requesting at least 4.65 million in financial aid from the city. Could the developer consider reducing the size of the project so that they do not need to rely so much on city funds?
- 5. The East Lake district is the "Action" side of the city. We have the Stadium, planned sports complex, Sky Diving, Motor cross. A concern if you keep approving housing developments, you are limiting the potential for new and exciting "action" activities. The current council members are visionaries. Please consider the possibilities of new innovating sports or theme parks that would tie in better with our Dream Extreme vision. We have a finite amount of undeveloped land, which we should hold dearly. Please consider the future possibilities for that section of the city. We need more sources of revenue or jobs.
- 6. Civic Partners should reconsider their stance against a pool for their residents. As you are aware, our temperatures regularly get into the triple digits in the summer months. These families need the pool for exercise and as a stress reliever. The pool creates family bonding time and I feel would be much better utilized than the proposed tot lot and large open space being planned (with no shade trees might I add) Idle minds are the devils workshop. These kids will need a free form of entertainment. Considering the scale of this project, I don't think adding a pool would cut too much into their profits and I would ask that this be one of the conditions added prior to approval.
- 7. Have there been any environmental impact studies? As you are aware, the current Diamond Dr. / Railroad Canyon exit is not able to support the current amount of traffic. What will be done to help ease the negative impacts that will be created by the new homes? Can the road improvements be addressed first before any new construction is done?


