Recycling bottles and cans is one way for rePlanet to capture postconsumer recycled content for our packaging operations and truly create a vertically integrated full circle, sustainable business!

## AB 2020 Summary

In 1986, California enacted AB 2020, aptly named the "Bottle Bill." CalRecycle, officially known as the Department of Resources Recycling and Recovery, administers the Bottle Bill. Beverage containers covered under the act are subject to California Redemption Value (CRV), which is 5 cents for containers less than 24 ounces, 10 cents for containers 24 ounces or larger. Thanks to the CRV cash incentive, more than 300 billion aluminum, glass, and plastic beverage containers have been recycled since the program began in 1987.

Under the Bill all California full-line\* supermarkets which do not have a recycling facility within one half of a mile are declared to be an "unserved" by CalRecycle and must register one of the following options with the Recycling Division of the Department of Conservation:

1. Provide a recycling facility within one half mile to allow members of the public to recycle beverage containers.
2. Receive recyclables within the store during all hours the store is open
3. Pay a \$100 dollar per day fee to the state of California.

**\*14526.5.** "Supermarket" means a full-line, self-service retail store with gross annual sales of two million dollars (\$2,000,000), or more, and which sells a line of dry grocery, canned goods, or nonfood items and some perishable items. For purposes of determining which dealers are supermarkets, the department shall use the annual updates of the Progressive Grocer Marketing Guidebook and any computer printouts developed in conjunction with the guidebook.

## Best Management Practices Plan

rePlanet, LLC provides CRV (California Redemption Value) buyback services to grocery stores throughout the state of California. Our recycling centers are a pre-fabricated unit with a foot print of 498 square feet. The unit consists of two fully enclosed storage roll off bins that fit into a building façade and serves as the front of the facility. The unit is skid-mounted and moveable with a standard roll-off type vehicle and is not a mobile recycling unit.

During operating hours, the recycling center is staffed by a well-trained site attendant(s) who receives, weighs and stores the recycling materials in the storage bins. Clients are given a voucher redeemable for cash at the supermarket's cash register or customer service desk. The staffed hours are typically 10 am – 4:30 pm, 7-days a week or as posted.

The recycling centers only accept CRV glass, plastic and aluminum beverage containers. All recyclable materials are stored in roll-off bins and secured inside the facility. When full, the roll-off bins are picked-up and returned by a roll-off truck. The storage bin exchanges are scheduled weekly depending on the volume of the site in order to prevent storage bins from overflowing.

The recycling center is cleaned daily. Upon arrival and in preparation for opening, our site attendants pick up any accumulated litter/trash. If any debris or undesirable materials have been left, the site attendant arranges to have the debris removed. During the hours of operation, the attendant maintains cleanliness at the facility by regularly walking around and collecting any litter that may accumulate. The trash is kept in trash cans and discarded at the end of the day. When necessary, abandoned shopping carts are collected and removed.

All beverage container spills are cleaned with a mop and bucket and discarded in the grocery stores restroom. Each center is power washed twice a month. We have two commercial grade pressure washing / steam cleaning units capable of producing 3,500 psi and 200 degree temperature water. This effectively cleans the parking area pavement, sidewalk surfaces of dirt, grime, gum, drink stains and other surface debris. Additionally, our maintenance crews are trained in the importance of storm water management programs. We have the ability to block the storm drains and pump the waste water into the appropriate sanitary outlet which will protect the property owners and managers from storm water violations.

All recycling center facilities are visited by trained supervisors on a weekly basis.
