**Subject: Construction Contract Award for SB 821 Palomar/Murrieta Creek Regional Trail CIP Project No. Z30008**

### **Recommendation**

1. Award the Public Works Construction Agreement for the SB 821 Palomar/Murrieta Creek Regional Trail to Black Rock Construction.
2. Authorize the City Manager to execute the Agreement in the amount of \$506,000 to Black Rock Construction, in substantially the form attached and in such final form as approved by the City Attorney.
3. Authorize the City Manager to use the 10% contingency in the amount of \$50,600.
4. Authorize the City Engineer to record the Notice of Completion once it is determined the work is complete and the improvements are accepted into the City maintained roadway network.

### **Background**

On June 26, 2017, City received confirmation from Riverside County Transportation Commission (RCTC), that certain proposed project as part of SB 821 Grant were approved for funding. SB 821 Palomar (Murrieta Creek) Regional Trail was one of them.

On July 19, 2019, the project was advertised via Planetbids

On August 28, 2019, the bids were opened.

### **Discussion**

Contractor bids were opened publicly on August 28, 2019, at 2:00 p.m. The City received fifteen (15) bids from qualified contractors. The City received a bid protest stating the contractor was not performing 50% or more of the work. The City Engineer reviewed the protest and the bid proposal; concluding that the contractor was performing 50% or more of the work. Staff recommends the selection of the low bidder Black Rock Construction. The bid results are summarized below:
