GOOD FAITH ESTIMATES

The good faith estimates set forth herein are provided with respect to the 2019 Bonds in accordance with California Government Code Section 5852.1. Such good faith estimates have been provided to the District by Urban Futures, Inc., the District's Municipal Advisor (the "Municipal Advisor") in consultation with Stifel, Nicolaus & Company, Incorporated, the underwriter of the 2019 Bonds.

Principal Amount. The Municipal Advisor has informed the District that, based on the District's financing plan and current market conditions, its good faith estimate of the aggregate principal amount of the 2019 Bonds to be sold is \$5.23 million (the "Estimated Principal Amount").

True Interest Cost of the 2019 Bonds. The Municipal Advisor has informed the District that, assuming that the Estimated Principal Amount of the 2019 Bonds is sold, and based on market interest rates prevailing at the time of preparation of such estimate, its good faith estimate of the true interest cost of the 2019 Bonds, which means the rate necessary to discount the amounts payable on the principal and interest payment dates to the purchase price received for the 2019 Bonds, is 3.90%.

Finance Charge of the 2019 Bonds. The Municipal Advisor has informed the District that, assuming that the Estimated Principal Amount of the 2019 Bonds is sold, and based on market interest rates prevailing at the time of preparation of such estimate, its good faith estimate of the finance charge for the 2019 Bonds, which means the sum of all fees and charges paid to third parties (or costs associated with the 2019 Bonds), is \$270,364. Additionally, there will be an annual Trustee fee of approximately \$1,800 for as long as the 2019 Bonds are outstanding.

Amount of Proceeds to be Received. The Municipal Advisor has informed the District that, assuming the Estimated Principal Amount of the 2019 Bonds is sold, and based on market interest rates prevailing at the time of preparation of such estimate, its good faith estimate of the amount of proceeds expected to be received by the District for sale of the 2019 Bonds, less the finance charge of the 2019 Bonds, as estimated above, and any reserves or capitalized interest paid or funded with proceeds of the 2019 Bonds, is \$5.24 million.

Total Payment Amount. The Municipal Advisor has informed the District that, assuming that the Estimated Principal Amount of the 2019 Bonds is sold, and based on market interest rates prevailing at the time of preparation of such estimate, its good faith estimate of the total payment amount, which means the sum total of all payments the District will make to pay debt service on the 2019 Bonds, plus any finance charge for the 2019 Bonds, as described above, not paid with the proceeds of the 2019 Bonds, calculated to the final maturity of the 2019 Bonds, is \$11.13 million. Additionally, there will be an annual Trustee fee of \$1,800 for as long as the 2019 Bonds are outstanding.

The foregoing estimates constitute good faith estimates only and are based on market conditions prevailing at the time of preparation of such estimates. The actual principal amount of the 2019 Bonds issued and sold, the true interest cost thereof, the finance charges thereof, the amount of proceeds received therefrom and total payment amount with respect thereto may differ from such good faith estimates due to (a) the actual date of the sale of the 2019 Bonds being different than the date assumed for purposes of such estimates, (b) the actual principal amount of 2019 Bonds sold being different from the Estimated Principal Amount, (c) the actual

amortization of the 2019 Bonds being different than the amortization assumed for purposes of such estimates, (d) the actual market interest rates at the time of sale of the 2019 Bonds being different than those estimated for purposes of such estimates, (e) other market conditions, or (f) alterations in the District's financing plan, or a combination of such factors. The actual date of sale of the 2019 Bonds and the actual principal amount of 2019 Bonds sold will be determined by the District based on various factors. The actual interest rates borne by the 2019 Bonds will depend on market interest rates at the time of sale thereof. The actual amortization of the 2019 Bonds will also depend, in part, on market interest rates at the time of sale thereof. Market interest rates are affected by economic and other factors beyond the control of the District.
