FY2020-2021 Citywide Asphalt Maintenance Program CIP # Z10002

Recommendation

Approve & authorize the City Manager to execute Amendment No. 1 to the Agreement with NPG, Inc., and increase compensation by an additional \$379,960 for a not to exceed amount of \$599,960 plus 10% contingency for FY2020/2021, in substantially the form attached and in such final form as approved by the City Attorney.

Background

The City entered into an agreement with NPG, Inc. for Citywide Asphalt Maintenance Program Service on September 8, 2020, for a contract amount of \$220,000. NPG has completed several projects this fiscal year on behalf of the City. The following is a list of completed projects:

- Nichols Road to Bridge - Asphalt
- Ponte Verde, Ponte Fiera, Pointe Bianco - Crackfill
- Larson Road - Drain improvement and repair
- San Jacinto – Asphalt repairs
- W. Sumner Ave. & Main St. – Asphalt maintenance
- Franklin Street – Asphalt maintenance
- Sandpiper Drive – Asphalt maintenance
- Illinois St. & Lakeview – Asphalt maintenance
- Courte Rivera Street – Asphalt maintenance
- 411 Landstaff Street – Mill & Overlay
- Langstreet & Pottery – Mill & Overlay
- Langstaff & Pottery – Driveway asphalt repairs
- 31170 Wisconsin Street – Asphalt maintenance

Discussion
