

City of Lake Elsinore Planning Commission Meeting Minutes Tuesday, October 17, 2017

CALL TO ORDER

A Regular meeting of the Planning Commission of the City of Lake Elsinore was held in the Cultural Center, 185 North Main Street, on the above date. The meeting was called to order at 6:01 p.m. by Chairman Gray.

PUBLIC HEARING ITEM(S)

1) Planning Application No. 2017-11 - A Request to Legalize and Permit A 1,500 Sq. Ft. Detached Metal Storage Shed Located Near the Intersection of Third Street and Melby Drive (APN: 347-330-030).

The Public Hearing was opened at 6:04 p.m. There were no conflict of Interest disclosures. Administrative Clerk Wells affirmed receipt of Proof of Publication and noted that correspondence had been received.

Community Development Technician Poley presented the Staff Report.

The Commissioners discussed the construction of the permit and the use of the Project.

Poley provided printed photos for the Planning Commission.

The applicant Scott Osborn was available for questions.

The Commissioners had concerns about with the project and suggested that the item be continued to another date.

2) <u>Modification of Conditional Use Permit 2015-09 - Dream Center 114 E. Peck Street, APN 373-023-020.</u>

The Public Hearing was opened at 6:46 p.m. There were no conflict of Interest disclosures. Administrative Clerk Wells affirmed receipt of Proof of Publication and noted that correspondence had been received.

Principal Planner Kirk presented the Staff Report.

Commissioner Klaarenbeek questioned occupancy load.

The applicant Brett Masters addressed questions and explained use of the Project.

The Commissioner's had a discussion about the Project.

There being no further discussion on the Project, the Public Hearing was declared closed at 7:03 p.m.

3) Tentative Tract Map No. 37381 and Tentative Tract Map No. 37382 (Wasson Canyon)

Senior Planner Abraham presented the Staff Report. She stated that there were no changes or modifications made to the map from the previous approval.

Principal Planner Kirk stated that a letter was received was in opposition of the Project. He advised the Commissioner's what the letter stated.

A representative of the applicant Carlos Cuevas and Rudy Nunez (the Engineer) were available to answer any questions on the Project.

There being no further response to the Chairman's invitation to speak, the Public Hearing was declared closed at 7:37 p.m.

The Public Hearing was reopened 7:37 p.m.

4) <u>Planning Application No. 2017-37 (The Cottages): A Request By Civic Partners for the Approval of A Development of 143 Multifamily Residential Units and Related on and Offsite Improvements.</u>

The Public Hearing was opened at 7:52 p.m. Commissioner Carroll disclosed that he bid a project a few

years prior, for the applicants shopping center but stated he did not get the project. Administrative Clerk Wells affirmed receipt of Proof of Publication and noted that two emails had been received prior to the meeting, they were provided to the Commissioners.

Principal Planner Kirk presented the Staff Report.

The Commissioner's discussed the Project.

The applicant Jeff Pomeroy thanked staff for the work done on this project. He said the Conditions of Approval have been reviewed and he accepts them. He provided the Commissioner's with a tentative timeline on the Project.

The Commissioner's responded to the comments of the people appearing to speak. The Commissioner's discussed the Project.

There being no further response to the Chairman's invitation to speak, the Public Hearing was declared closed at 9:04 p.m.
