- 1) <u>Swearing In of New Commissioner</u> City Clerk Domen gave the Oath of Office to Kelly Hendley.
- <u>California Highway Patrol Safety Tips for Ortega Highway</u> Officer Lasich gave a report on the incidents and fatalities of the Ortega Highway, provided safety tips, and responded to the Commissioners questions.

Chair Stewart introduced Chief of Police, Chief Anne.

Chief Anne introduced himself, gave statistics on incidents within the City, thanked the community for their tips, and responded to the Commissioners questions.
