

City of Lake Elsinore Planning Commission Meeting Minutes Tuesday, September 18, 2018

CALL TO ORDER

A Regular meeting of the Planning Commission of the City of Lake Elsinore was held in the Cultural Center, 185 North Main Street, on the above date. The meeting was called to order at 6:00 p.m. by Chairman Ross.

There were no members of the public appearing to speak.

It was moved by Commissioner Gray, seconded by Commissioner Klaarenbeek, and carried to approve meeting minutes.

2) Planning Application No. 2018-31- A Request for the Construction of a Single-Family Residence of 2,068 Square Feet with an Attached 427 Sq. Ft. Two Car Garage Located Near the Intersection of Sumner Avenue and Matich Street. (APN: 374-101-007).

The Public Hearing was opened at 6:02 p.m. There were no conflict of Interest disclosures. Administrative Clerk Wells affirmed receipt of Proof of Publication and noted that no correspondence had been received.

Community Development Technician Poley presented the Staff Report.
